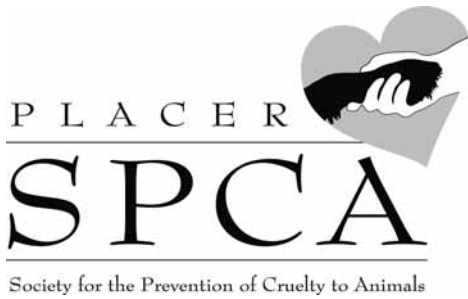

Vendor Rules and Regulations

We must receive a signed Agreement prior to the event.

Vendor Fee: \$100

1. Placer SPCA's, herein after called "PSPCA", Barktoberfest is an activity held outdoors. An outdoor, 10' x 10' area will be provided.
 - a. **Vendor is responsible for providing own table, chairs, tent, and other needs for set-up and service (i.e. carts, change, etc.).**
2. Concessionaire shall have the *non-exclusive* right to sell items approved in writing by PSPCA.
3. **Term of this contract is 7:00 am to 4:00 p.m. October 3, 2010.**
 - a. **Set up may begin on Sunday, October 3, 2010 at 7:00 a.m. at Renesas Electronics America, Inc. (7501 Foothills Blvd., Roseville, CA)**
 - b. Vehicles used to deliver items to booths will be parked in the designated vendor parking lot and not be able to return to their booth until after the event closes at 2:00 p.m.
 - c. Each vendor will receive one parking pass prior to the event.
4. Booth space may be applied for prior to September 30th.
5. **All payments must be received prior to September 30th.**
6. **There will be no allowances made for beverage and food sales/distribution, unless pre-approved by the PSPCA per Placer County Health & Human Services regulations.**
7. Vendors hereby waive all claims and recourse against the PSPCA including the right to contribution of loss or damage to persons or property in any way connected with Barktoberfest.
 - a. Vendor will indemnify and hold Placer SPCA harmless from all costs, losses, damages, or expenses including expense of litigation, and attorney's fees, resulting from any person or property arising out of any act of omission of vendor or his employees or other representatives at the Barktoberfest.
